NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister of Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act.

I declare that the 'Runaway Barossa Marathon' is an event to which this section applies and that the following roads be closed to vehicle traffic the following times on Saturday 21 October 2017:

Within The Barossa Council: -

- Para Road, Tanunda between Murray Street and Langmeil Road
- Langmeil Road, Tanunda between Para Road and Bridge Street
- Stelzer Road, Tanunda between Council Boundary and Langmeil Road
- Bridge Street, Tanunda between Langmeil Road and Murray Street
- Elizabeth Street, Tanunda between Murray Street and Ellen Place
- Ellen Place, Tanunda between Elizabeth Street and Jane Place
- Jane Place, Tanunda between Ellen Place and Council Boundary
Between 5.00am and 9.30am

- Golflinks Road, Rowland Flat between Council Boundary and Barossa Valley Way
Between 6.30am and 10.00am

- Herman Thumm Drive, Lyndoch between Barossa Valley Way and Council Boundary
Between 7.30am and 1.15pm.

Within the Light Regional Council: -

- Jane Place between Ellen Place and Presser Road
- Presser Road between Smyth Road and Gomersal Road
Between 5.00am and 9.30am

- Gomersal Road between Gerald Roberts Road and Golflinks Road
Between 6.30am and 1.15pm

- Golflinks Road between Gomersal Road and Barossa Valley Way
Between 6.30am and 10.00am

- Lyndoch Road between Hermann Thumm Drive and Gomersal Road
- Gerald Roberts Road between Gomersal Road and Heinze Road
Between 7.30am and 1.15pm

- Heinze Road between Gerald Roberts Road and Stonewell Road
Between 5.00am and 1.15pm
- Neldner Road between Heinze Road and Kraehe Road
- Kraehe Road between Neldner Road and Seppeltsfield Road
Between 5.00am and 1.30pm
- Seppeltsfield Road between Stonewell Road and Radford Road
- Nitschke Road between Seppeltsfield Road and Roenfeldt Road
- Roenfeldt Road between Nitschke Road and Stonewell Road
- Stonewell Road between Roenfeldt Road and Heinze Road
- Mattiske Road between Stonewell Road and Stelzer Road
- Stelzer Road between Mattiske Road and Langmeil Road
- Jenke Road between Neldner Road and Stonewell Road
- Alm Road between Heinze Road and Jenke Road
Between 5.00am and 3.30pm

I direct that persons taking part in the 'Runaway Barossa Marathon' on the above road be exempted from all Australian Road Rules relating to pedestrian behaviour on roads.

I also hereby authorise Ironman Oceania or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

I direct that the installation and removal of necessary and appropriate traffic control devices for the conduct of this event can only be performed by a person with work zone traffic management training.
