Under Section 70(a1) of the Local Government act 1999 (“the Act”) the Council must publish on its website the following details about a Council Member as recorded in the Register of Interests:

- The member’s income sources (within the meaning of Schedule 3 of the Act) or employer;
- The name of any political party, any body or association formed for political purposes or any trade or professional organization (within the meaning of Schedule 3 of the Act) of which the member is a member
- Any gifts received by the member that are required to be included in the information entered in the Register in relation to the member.
