

APPLICATION FOR PERMIT FOR HARVESTING OLIVES

PURSUANT TO LIGHT REGIONAL COUNCIL BY-LAW Section 7 No. 4

I ("the Permit Holder")
of

hereby make application to **LIGHT REGIONAL COUNCIL** ("the Council")

for a permit to use sections of the public road for harvesting olives from olive trees located within council controlled road reserves in accordance with the information described below.

Location of the road : Public Road Reserves within the boundaries of Light Regional Council, excluding those portions of arable Road Reserve which are subject to a Permit for a business purpose pursuant to Section 222 of the Local Government Act 1999 ("the defined area")

THE APPLICANT HEREBY AGREES THAT THE APPLICANT SHALL:-

A. Comply with the General Conditions of the Permit as contained herein;

GENERAL CONDITIONS OF PERMIT:-

1 Term of Permit

The Council hereby grants to the Permit Holder a Permit to use the defined area for a term commencing on the ___ day of _____2011
and expiring on the ___ day of _____2012
subject to the terms and conditions contained herein.

2 Indemnification of Council and Insurances

The Permit Holder agrees to indemnify the Council against any liability that may arise by reason of the use of the defined area.

Further, the Permit Holder agrees to take out and keep current for the term of the Permit Public Risk Insurance insuring the Permit Holder against all actions, costs, claims, charges, expenses and damages whatsoever which may be claimed against the Council or the Permit Holder or both in relation to the use of the defined area.

3 Occupational Health, Safety and Welfare Act

The Permit Holder agrees, in the use of the defined area, to have due regard to the Occupational Health, Safety and Welfare Act.

4 Compliance with Road Traffic Act

The Permit Holder shall in all activities on the defined area comply with the requirements of the South Australian Road Traffic Act, 1961 and the Australian Road Rules.

5 Sub - Permit of Defined Area

The Permit is not transferable.

6 Keep in Good Repair and Condition

The Permit Holder shall not take any action that will or is likely to cause degradation of the defined area, infrastructure within the road reserve, native vegetation or any nearby land.

7 Sale of Goods

The Permit Holder shall not permit or allow to be conducted at or about the defined area any activity involving the sale of goods or the supply of services of a potentially profit making nature without the prior written consent of the Council.

8 Determination of Agreement

In the event of any breach or default by the Permit Holder or the non-observance of any provision or condition of the Permit the Council may forthwith revoke the Permit.

An application for a permit signed by both parties shall be deemed to constitute a permit.
