On 29 August 2013 the Code of Conduct for Council Members ('the Code') was gazetted by the South Australian Government.

The Code, which is to be observed by all Council Members (*reference Section 63(1) and (2) of the Local Government Act 1999*), is a public declaration of the principles of good conduct and standards of behaviour that Elected Members of Light Regional Council believe its stakeholders can reasonably expect Members of Council to demonstrate in the performance of their responsibilities.

The standards of the Code are in addition to any statutory requirements of the Local Government Act 1999 or any other relevant Act or Regulation.

It is therefore appropriate that the Code of Conduct for Council Members is extended to include and be read and observed by all Committee Members; which shall comprise Independent Members, appointed to a Committee of the Light Regional Council.

By resolution of Council dated Tuesday, 24 November 2015 all Committee Members, including Independent Members, appointed to a Committee of the Light Regional Council shall:

- observe and conduct themselves; and
- be subject to the conditions imposed

in accordance with the Code of Conduct for Council Members Gazetted 29 August 2013 and any amendments thereto.
