

The Light Region

The Light Region, located an hour north of Adelaide, is 1,278km² in size and features numerous towns and the suburb of Hewett, separated by productive agricultural land. The area includes a significant part of one of Australia's best-known international brands, the Barossa Valley wine region.

Townships within the Light Regional Council area include Kapunda, Freeling, Gawler Belt, Greenock, Hewett (suburb), Roseworthy and Wasleys as well as several smaller settlements, such as Allendale North, Buchfelde, Daveyston, Hamilton, Nain, Seppeltsfield, and Templers.

The Light Regional Council area includes land that is a part of traditional Kurna and Ngadjuri Country. The Kurna and Ngadjuri people have a deep connection with this land established over thousands of generations, which is acknowledged and respected.

Following European settlement in South Australia, Light's local economy was initially founded on mining (through Australia's first commercial copper mine in Kapunda in 1842) and agriculture. Agriculture, including viticulture, remains an important export industry today, with supporting manufacturing industries also providing significant jobs.

Kapunda is a 'District Centre' in the *30 Year Plan for Greater Adelaide - 2017 Update*. It is expected that Kapunda will continue to accommodate a range of retail facilities, offices and consulting rooms, cultural, community and public administration; entertainment, educational, religious and residential facilities; to serve the community and visitors within the surrounding district.

Further population growth at Roseworthy is commencing after several years of planning and is expected to deliver an additional population of 10,000 people plus new retail and community facilities by 2035.

Light Regional Council is fortunate to have high performing agricultural land, renewable energy resources (particularly solar and wind), enhanced recycling opportunities for water and waste, and active mineral tenements.

We also recognise that our region, like all others, is significantly influenced by global factors that can have a huge impact on our local people, economy, and environment. Front-of-mind at the moment are:

- Global export markets involving changing economic powerhouses for our primary producers, vignerons and manufacturing industry.
- Global climate changes and the resulting urgency for adaptation and playing our role in a just transition to a low-carbon future.
- Digital disruption and technology, with businesses transitioning towards the fourth industrial revolution.

Council's Strategic Plan seeks to highlight the roles that Council can play in supporting our community to thrive in the face of these global issues.

History of our Logo

A corporate logo plays a significant part in creating a sense of ownership and pride in the community. Successful branding promotes positive perceptions, not only to the local community, but also visitors to the area and the wider environment in which Council operates.

In identifying the importance of community ownership the Council has also placed a series of township signs at Freeling, Greenock, Hewett, Roseworthy, Wasleys, Marananga, Seppeltsfield and Kapunda. These signs identify qualities and characteristics that are unique in each town.

Our logo was designed to incorporate the life blood of the district. The solid green represents the pastures, the striped green represents the vineyards, the brown strip is the earth, the gold crosshatching represents the crops, blue is for the River Light and the sun represents a positive future for the people of the district and Council.



About your area

Freeling

Robert Stephenson first surveyed the area on which the township of Freeling stands in March 1869. It was named Freeling after Major-General Sir Arthur Henry Freeling, Baronet, who was the Surveyor General of South Australia from 1849 to 1861.

Freeling was developed early in the State's history because of the large agricultural region surrounding the town. The town itself was set on gently undulating land amidst eucalyptus woodland. When most of the woodland was cleared, farms were established in a region with a climate that is described as "mildly Mediterranean".

The area became a major wheat growing district and in the early 1900's was the largest hay-producing centre in South Australia. Haystacks were so large, they could be seen for miles.

Because of its location, Freeling became a focal point for the Barossa Valley and people travelling towards

the River Murray. It was also a major link for travellers going from Gawler to Kapunda and continuing on to northern regions.

Freeling also became an important manufacturing centre that produced thousands of implements used on farms and vineyards throughout Australia and the world. The region became more renowned during the 1900's, when chaff cut from steamed hay, arrived in good condition in India for the British Army horses.

The legacy of the early pioneers who established Freeling, is a town with a strong sense of community and pride, in a region where large quantities of excellent wheat are still being grown to this day.

Freeling also has a high status within the engineering industry, with the largest supplier of precision ground engagement tools produced in Australia located in the centre of the town.

About your area

Greenock

Sometimes referred to as a “little Scotland in the Barossa Valley”, the region is believed to have been named by James Smith, the secretary of George Fife Angas, after the town of Greenock at the mouth of the River Clyde, in Scotland. The name Greenock literally means ‘sunny hill’ and is derived from the Gaelic words ‘*grain*’ meaning sun and ‘*cnoc*’ which means hill.

In 1846, one year before land for the present township was released, The Greenock Creek Mining Company started to mine an area five kilometres south of where Greenock was eventually established. However, mining ceased after only one year and it was another four years before subdividing of the town took place.

The township of Greenock was initially established from a subdivision of land that belonged to the Bevan family.

The first portion of land was sold to James Jackman of Gawler, in September 1850. That land was developed as the “Greenock Arms Hotel”.

The hotel became a significant relay station for district mail coaches and teamsters hauling both primary produce from the Barossa Valley and copper from the Kapunda Mines.

Today Greenock exudes “olde-worlde” charm, but don’t be deceived, this town’s community spirit continues to drive it forward.

About your area

Hewett

Hewett is largely a residential suburb populated by families and has a range of local services including a deli, takeaway, pharmacy, bakery and more. It also has a recreation precinct, Child Care, Elsie Ey Childrens Centre, Hewett Primary School, and a community facility in the Hewett Centre available for hire, functions, events and community programs.

This area began with two estates, Harkness Heights McKinlay Estate, and McKinlay Ridge. Originally farming land, the area is named after William Arthur Hewett, a local landowner. Since then, more estates have been established.

Harkness Heights was the first estate to be established in Hewett and is named after Laurie Harkness; a local resident who played a key role in the development of the spectacular hybrid bottlebrush that bears his name.

The development of McKinlay Estate commenced in April 2001. The estate was named after “Big” John McKinlay who was born in Scotland in 1819 and migrated to Australia when he was seventeen. He became a well-established pastoralist in NSW and Victoria and made several excursions between the Darling River, NSW and Lake Frome in SA.

In 1861, he organised an expedition to search for and rescue explorers Robert O’Hara Burke and William John Wills. Leaving Adelaide on 16 August 1861, he soon learned that he was too late to save anyone from the ill-fated expedition, so he headed toward the Gulf of Carpentaria. Unable to reach the Gulf due to the difficult terrain, he continued to the North Queensland coast and returned to Adelaide by sea. In 1865 he was commissioned to explore the Northern Territory on behalf of the Government and to report on the best sites for settlement.

McKinlay returned to SA in September 1866 and became a pastoralist near Gawler, where he stayed until his death on 31 December 1872.

The residential developments at Hewett offer wonderful opportunities for new residents to experience the ultimate in township and country living, and to be involved in creating a friendly community atmosphere.

About your area

Kapunda

The name Kapunda is believed to have been taken from 'Cappie Oonda', a local Indigenous phrase for 'water jump out' - probably a spring.

The town became the first established mining town in South Australia soon after Captain Charles Hervey Bagot discovered copper in 1842. Mining began in 1844 and continued until 1879 when world copper prices fell. Although copper was mined for only a brief period, revenue from its sale helped save South Australia from bankruptcy. When the railway was established in 1860, Kapunda became the rural centre for the mid-north of the State.

Kapunda has produced many of South Australia's most significant people. Since 1857, thirty-one of the State's Members of Parliament were either born in Kapunda or had lived in the town at some stage during their lifetime. Four of these men became Premiers of South Australia and two went on to become Premiers in Western Australia and Tasmania.

Sir Sidney Kidman first passed through Kapunda in 1871. He went on to become one of Australia's largest landowners and returned to Kapunda where he married local schoolteacher, Isabel Brown Wright in 1885. Sir Sidney and Isabel Kidman lived in Kapunda until 1921. His horse sales in the town were reputed to be the largest in the world. Sir Sidney

became a generous benefactor to the town, even donating his home, 'Eringa' to the Education Department when he moved to Adelaide in 1921. The residence is now the administration building for the Kapunda High School.

In 1857 Henry Binney Hawke established HB Hawke & Co Engineering and created the first hydraulic car hoist in Australia, the broadcast seed-sewing machine and the weighbridge. HB Hawke & Co was an integral part of the region's survival and success for 126 years, until the company closed in 1983.

Amongst the several well-known pastoralists who lived in the area, the name Dutton stands out. The Dutton family features strongly in the history of the region.

During the 1800's, Frederick Dutton was also one of the town's main benefactors and his financial support sustained Dutton Park, the Kapunda Hospital, the Institute, The Show Society and many clubs and groups which would have ceased but for his timely intervention. In 1839 the area known as "Anlaby", a pastoral station was established and continued to be part of the Dutton Family estates until the late 1900's.

Today Kapunda is developing both residentially and industrially, but it retains a relaxed country atmosphere that is enjoyed by residents and visitors alike.

About your area

Wasleys

Wasleys was established in an area known as the Mudla Wirra Forest. The name Mudla Wirra is a local Indigenous term, 'Mudla' meaning 'implement' and 'Wirra' meaning 'forest'. The town of Wasleys is situated on an area first known as "Ridleyton", which was named after John Ridley, the person that laid out the nearby village of Ridley in 1873. The railway had been extended through the region in 1869 and a railway station was erected on land purchased by Joseph Wasley, one of the first settlers to the area.

The township was advertised to attract people seeking good agricultural land as "Ridley Township - Wasleys Station". In time, two townships were announced and called, Ridleyton and Wasley. As the towns grew, the name Ridleyton was discarded and the town became known as Wasleys.

Early settlers soon made their mark on the history of the region. In 1843, John Ridley revolutionised the agricultural industry with the first "stripper machine",

which stripped crops quickly and cheaply with a minimum of labour.

In the 1860's, a local farmer named Charles Mullen created a method of ploughing which was known as "Mullenising". Mullen invented an implement, used throughout Australia, which was the precursor of the stump-jump plough.

During 1866-1877, pioneer farmer Richard Marshall succeeded in solving the "red rust" problem in wheat by crossbreeding various wheat varieties and improved soil conditions using bone meal on the land. After good crop returns, a student at Roseworthy College named Charles Deland, led a campaign in favour of fertilizer.

Wasleys became a thriving centre and once operated three chaff mills. Although the mills have ceased operating, the town is still a focal point for agriculture and farming livestock and, as reported in *The Bunyip* on 27 September 1873, "There can be no question that this is an excellent locality for a township."

About your area

Roseworthy

On 13 December 1837, Colonel William Light, Surveyor General of South Australia, visited the area which would eventually become the township of Roseworthy.

In 1855, William and Grace Gartrell purchased land in the Hundred of Mudla Wirra, an Indigenous name meaning *'implement'* and *'forest'*. When her husband died in 1863, Mrs Gartrell subdivided the land for a township and named it Roseworthy after a village in Cornwall. The name Roseworthy is derived from the Cornish word *'Roswartha'*, meaning Meadow Heath.

On 5 July 1869, Roseworthy became a major rail link for passengers travelling to and from Morgan, Gladstone and Terowie. The station also became an important junction for the link to Kapunda and Burra.

In 1881 the Government purchased land to establish an experimental farm in the region and in 1883 reconstituted the farm as a college. Roseworthy Agricultural College became the first of its kind in Australia and is now a major contributor to agricultural teaching and research, as well as veterinary science.

Roseworthy is now a thriving community set to grow over the next 30 years in a region recognised for its significance in the wine, grain, sheep and other animal husbandry industries.



- SA Property and Planning Atlas (SAPPA)





Explore | Learn | Enjoy




The Light Regional Public Libraries are community places for people of all ages to read, learn, access information, and meet old and new friends.

Kerbside Waste Collection

Council provides a kerbside waste management service to townships and portions of rural areas.

Townships are provided with a 3-bin service and rural areas a 2-bin service.

Townships - Mandatory 3-Bin Service - 140 litre red lidded general waste bin (weekly collection), 240 litre yellow lidded bin for recycling (fortnightly collection) and 240 litre green organics bin (fortnightly collection - on alternate week to recycling bin pickup).

Rural areas – 2-Bin Service - 140L general waste (weekly collection) and 240L recycling (fortnightly collection) only.

Commercial properties within any zone are eligible for a 2-bin service only (unless otherwise authorised) with a configuration of a 240-litre red lidded general waste bin and a 240-litre yellow lidded recycling bin.

Council does not include refuse collection fees within the rating fees prescribed per year; the

refuse fee is a separate charge. Not every property within the Council area can receive a service due to location or available access to the property.

Refuse collection and disposal fees may alter per financial year, subject to Council resolution.

For all enquiries relating to your new or existing bin service, please contact **Solo Resource Recovery** on **8295 5077**.

Bins remain the property of Solo Resource Recovery and are fitted with an RFID tag that identifies the property each bin is assigned to.

Bins have a weight limit of 75kg. Bins exceeding this limit will not be lifted and emptied.

Dog Registration

All dogs aged three months or over must be registered. Registering your dog provides council with a description of your dog, identifies you as the owner and lists contact information. If your dog is wearing its collar and registration disc and becomes lost or goes wandering, it can be quickly re-united with you. The registered owner must be a person aged sixteen years or over.

All dogs within South Australia are now registered in a central online database called Dogs and Cats Online (DACO). The system allows pet owners to self-manage their details; owners can instantly update registration or microchip details if they move house or change phone numbers and pay their annual dog registration fee. It will also allow pet owners to register a new dog without the need to visit a Council office.

New owners have fourteen days to register their dog once they take ownership or become responsible for the dog. An expiation notice may be issued if the dog remains unregistered after the fourteen-day period.

Effective 1 July 2018 it is compulsory for all dogs **and** cats to be microchipped. All dogs and cats born on or after 1 July 2018 must be desexed. There are certain exemptions for workings dogs and registered breeders.

To register a dog with Council you will need to:

Visit the DACO website at www.dogsandcatsonline.com.au, where you can register a new dog or update your dog's details if you have moved from another Council area within South Australia.

Payment for registrations can be made online on the DACO website by credit card, or alternatively you can visit one of Council's offices or libraries if you wish to pay by cash or cheque.

When do I have to renew my dog registration?

Dog registrations are due from 1 July and must be renewed by 31 August **each year**.

Owners of dogs who have not renewed the registration by 31 August each year will incur a \$20.00 late payment fee in addition to the applicable renewal fee and may receive an expiation notice for having an unregistered dog.

Registration Fees from July 2023

A Non-Standard dog registration fee is \$77. This fee is set by Council and may change from year to year.

Dog owners who hold a concession card will receive a 50% rebate on the fee otherwise payable. A current concession card must be produced at the time of claiming this rebate.

Dog owners are eligible for a 50% rebate if the dog has been desexed **and** microchipped.

If a person has a desexed dog that is not microchipped, they will receive a 40% rebate off the maximum fee. Owners registering a desexed dog for the first time must produce a certificate of desexing issued by a veterinary surgeon to receive the rebate.

Dog owners who microchip their dogs without desexing will be given a 10% rebate off the maximum fee. To be eligible for this rebate, a micro-chipping certificate must be presented at the time of registering the dog.

No burning is allowed in township areas unless your property is more than 1 acre in size (permit is required)

1 March - 30 April - permit required for stubble burn off

Fire Danger Season

District - Mid North

Start Date - 1 November

Finish Date - 30 April (midnight)

* Start date is subject to change at any time.

Burning Outside of the Fire Danger Season

To be able to burn within any of our townships the property needs to be at least one acre (4,000 square metres) in size.

If the property is at least one acre, the General Inspector will need to visit and inspect the area before a permit can be issued.

If a permit is issued, the allowed burning hours are between 10.00 am and 3.00 pm Monday - Saturday. No burning is permitted on Sundays or Public Holidays.

If you are wanting to have a small fire (a comfort fire), it needs to be no bigger than one metre square.

The General Inspector will also need to attend and inspect the location before issuing a permit.

Incinerators are not allowed to be used within towns.

Total Fire Ban Days

The declaration of a Total Fire Ban can be made at any time of the year and may fall outside of the declared Fire Danger Season. A Total Fire Ban may be declared for anyone, or for all Fire Ban Districts, and will be released to the media on the evening prior to the Total Fire Ban Day to coincide with nightly news broadcasts.

Environmental Health

Septic Tanks

Most residential properties within the Light Regional Council area dispose of wastewater via a septic tank system.

The following is a list of items that are prohibited discharges to the system:

- Any storm water including roof and rainwater overflow
- Any sanitary napkin, clothing, plastic material or liner
- Any trade waste
- Any petrol, flammable or explosive substance
- Any disinfectant, deodorant or antiseptic unless stated as being suitable for use in a septic tank
- Any other matter or substance that would impair the effectiveness of the system

Note: all septic tanks should be de-sludged every 4 years to maintain an effective primary treatment.

All residential properties connected to the township Community Wastewater Management System will be de-sludged every 4 years by Council's contractor.



European Wasps

If you locate a European Wasp nest, contact Council's Environmental Health Officer on 8525 3200 to arrange for the nest to be destroyed and removed.

Food Complaints

All inquiries regarding food health complaints or food businesses should be referred to Council's Environmental Health Officer on 8525 3200.

Immunisation

Council undertakes school immunisation at secondary schools in accordance with schedules from the South Australian Department of Health. Information of past vaccinations at schools may be obtained by calling Council's Environmental Health Officer on 8525 3200.

Wastewater System Applications

All new waste control systems or alteration to existing systems require an application to be lodged and approved by Council under the SA Public Health Act 2011.


